

**ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of this Corporation is Richard W. Buck, PA

ARTICLE II - EFFECTIVE DATE

This Corporation shall be effective on January 1, 2004.

shares of common stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of the common stock may be paid for at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. (b) Preemptive Rights. Shareholders shall have no preemptive rights.

(c) Cumulative Voting. Cumulative voting shall not be permitted.

(d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this Corporation as they may see fit.


