The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1: Name. The name of the Corporation is: ABSOLUTE QUALITY CLEANING, INC.

Article 2: Effective Date. Pursuant to section 607.123, Florida Statutes, the effective date of the Corporation shall be January 2, 2004.

Article 3: Duration. The duration of the Corporation is perpetual.
