ARTICLES OF INCORPORATION OF

CECRETARY OF STATE TALLAHASSEE, FLORIDA

HOME DETAILERS PAINTING, INC.

The undersigned, being of legal age and competent to contract for the purpose of organizing a business corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation under Florida Statutes, Chapter 607, and other laws of the state of Florida, and does hereby agree and certify as follows:

ARTICLE (NAME

The name of this Corporation shall be HOME DETAILERS PAINTING, INC. (herein "Corporation").

ARTICLE II COMMENCEMENT OF CORPORATE EXISTENCE

This corporation shall commence corporate existence immediately upon filing with the Florida Department of State, and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III PURPOSES AND GENERAL POWERS

The Corporation is formed to engage in every phase and aspect of painting work on commercial and residential jobsites throughout the United States that is deemed viable and profitable. This Corporation shall have all of the powers enumerated in the Florida Business Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law, including, without limitation and only by illustration, the following:

- (a) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- (b) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real personal property or any interest therein, wherever situated.
- (c) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- (d) To lend money to, and use its credit to assist, its officers and employees.
- (e) To make contacts and guarantees and incur liabilities, between money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- (f) To enter into, make, receive assignments of, grant assignments of, and perform contracts of every nature and kind for any lawful purpose. To enter into, make, receive assignments of, grant assignments of, and perform contracts of every nature and kind for any lawful purpose.
- (g) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

- (h) To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida Business Corporation Act or by other applicable law within or without the State of Florida.
- (i) To elect or appoint officers and agents and define their duties and fix their compensation.
- (i) To make and after bylaws, not inconsistent with its Articles of incorporation or with the laws of the State of Florida, for the administration and regulation of its affairs.
- (k) To promote, by all proper and legitimate agencies and means, education and educational institutions generally, and any and all charitable, religious, scientific and educational movements, purposes or causes, to make gifts and donations for the public welfars or for charliable, religious, scientific or educational purposes.
- (I) To transact any lawful business, which its Board of Directors shall find, will be in aid of governmental policy.
- (m) To pay pensions and establish and carry out pension plans, profit sharing plans, stock bonus plans, retirement plans, benefit plans, stock option plans, and other incentive and compensation plans for may or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries.
- (n) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his or her death shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (o) To be a promoter, incorporator, general partner, limited partner, member, associate, or manager of any corporation, partnership, limited partnership, joint venture, trust, or other enterprise.
- (p) To have and exercise all powers necessary or convenient to affect its general purpose.

ARTICLE IV CAPITAL STOCK

Number and Class of Shares Authorized Par Value.

The capital stock authorized, the par value thereof, and the class of such stock shall be as follows:

Voting Rights.

Shareholders shall possess and exercise exclosive voting rights and at all meetings of the shareholders, each record holder of such stock shall be entitled to one vote for each share held.

Restraint On Alienation Of Shares.

The sharcholders of the Corporation shall have the power to include in the Bylaws, or by separate agreement adopted by a majority of the shareholders of the Corporation, any regulatory or restrictive

The manuer and form, as well as the relevant terms, conditions and details, of the disposition shall be determined by the shareholders of the Cornoration; provided however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the awaership of such stock.
