**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, GEORGE WILLIAM SCHMITZ, JR., a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, *Florida Statutes*.

ARTICLE I - NAME

The name of this corporation is SCHMITZ BROTHERS REMODELING AND REPAIR, INC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of the principal office of the corporation is 7430 Churchill Place, Pensacola, Florida 32526.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK
