**ARTICLES OF INCORPORATION
OF
COGON SYSTEMS, INC.**

In compliance with chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is Cogon Systems, Inc. ("Corporation").

ARTICLE II

The existence of the Corporation shall begin on December 29, 2003, and shall be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is 31 West Garden Street, Suite 205, Pensacola, Florida 32502.

ARTICLE IV

The Corporation is authorized to issue 5,000,000 shares of common stock ("Common Shares"). All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each Common Share on all matters on which shareholders have the right to vote. The Corporation is also authorized to issue 1,000,000 shares of preferred stock ("Preferred Shares"). The board of directors is authorized to provide for the issuance of such Preferred Shares in 1 class and, by filing the appropriate articles of amendment with the Secretary of State of Florida, is authorized to establish the preferences, limitations, and relative rights of the Preferred Shares.

ARTICLE V

The initial street address of the Corporation's registered office is 501 Commonwealth Street, Pensacola, Florida 32502. The initial registered agent for the Corporation at that address is Beggs & Lane, RLLP.

ARTICLE VI

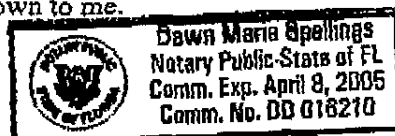
