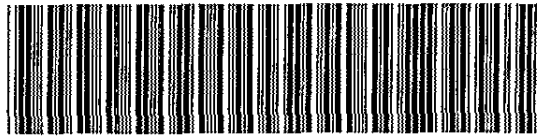



ARTICLE I

CORPORATE NAME




