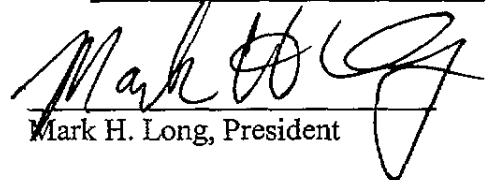
ARTICLE VII--AMENDMENT

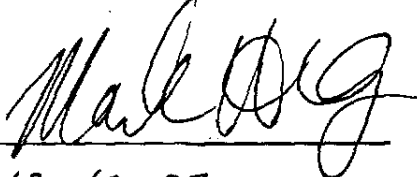
