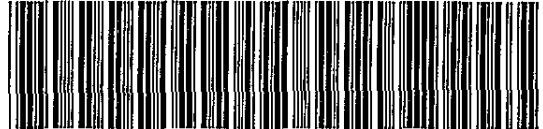

The name of the corporation is WALK ON TILE, INC.


ARTICLE IX. AMENDMENTS

In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date of the filing of these Articles of Incorporation.

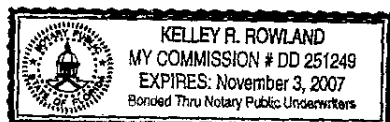
