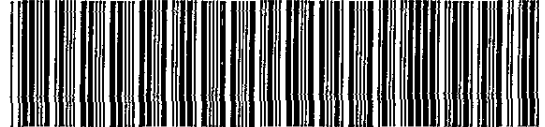

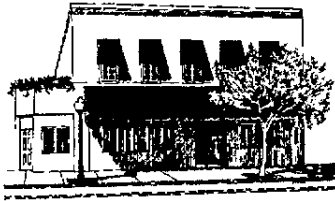

**ARTICLE I-Name**

The name of this corporation is Building Designs, Inc.

**ARTICLE II- Principal Office**

The address of the principal office is 2370 Preston Avenue, Sebring, Florida 33872 and a mailing address of 2370 Preston Avenue, Sebring, Florida 33872.

**ARTICLE III-Duration**

This corporation shall have perpetual existence.

**ARTICLE IV-Purpose**

ARTICLE XI-Amendment

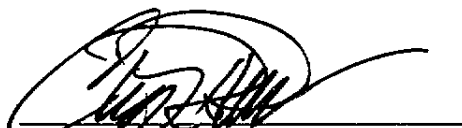

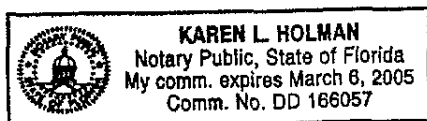
