ARTICLES OF INCORPORATION

OF

UP AND IN INSTALLATION, INC.

ARTICLE I - NAME

The name of the corporation is Up and In Installation, Inc., at 235 Bristol Court, Melbourne, FL 32935 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
