

ARTICLE I - NAME

The name of this Corporation shall be:
Kein Construction, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 01/01/04.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting

ARTICLE X - BY-LAWS


The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors and the Shareholders.
