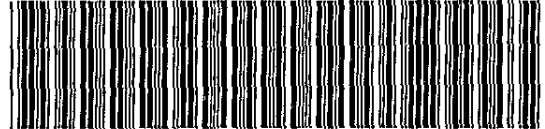



ARTICLE I. NAME

ARTICLE II. DURATION OF THE CORPORATION
