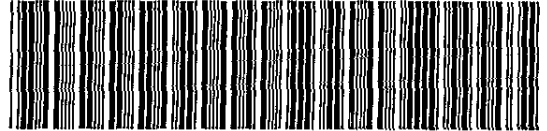

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: SKEETER DONE RESCREENING, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 40123 Stewart Road, Zephyrhills, FL 33540.

The principal mailing address of this corporation shall be: 40123 Stewart Road, Zephyrhills, FL 33540.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of rescreen services; and
2. 
