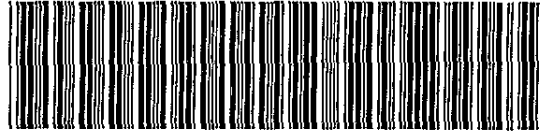


The UNDERSIGNED acting as incorporator of a corporation adopts the following articles of incorporation for such corporation.
