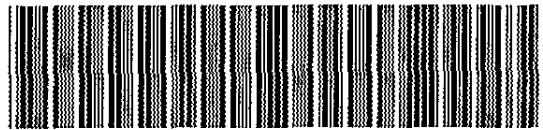

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned being a natural person, does hereby act an incorporator in adopting and filing the following articles of incorporation for the purposes of organizing a business corporation in Florida.
