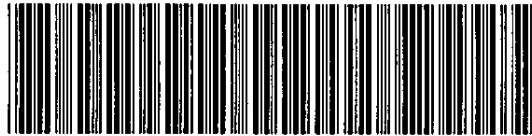

Pursuant to the provisions of Sections 607.1003 and 607.1006, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

Amend Article I of the initial Articles of Incorporation of the Corporation to: The name of the Corporation is J & Y Wheeler, Inc.

SECOND:

All certificates of shares of stock in Southeastern Renovations, Inc. shall be returned to the Corporation for exchange. 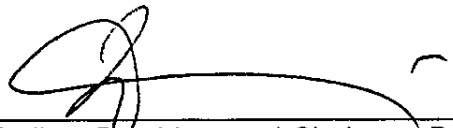
THIRD:
