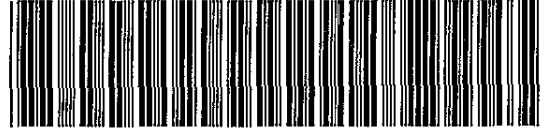

ARTICLE I - NAME

The name of this professional corporation is: ARGELIO TORRES, C.P.A., P.A.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be transacted by this professional corporation is the rendering of public accounting services. In connection with the above-mentioned purpose, this professional corporation shall have power to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, or own real or personal property necessary for the rendering of professional services, and do all other acts permitted under the laws of the United States and under the laws of the State of Florida.






