

ARTICLES OF INCORPORATION

OF

TOTtrak, Inc.

The undersigned, acting as an incorporator in compliance with Chapter 607 and/or Chapter 621, Florida Statutes hereby adopts and executes the following Articles of Incorporation.

ARTICLE I

Name

The name of this corporation shall be TOTtrak. Inc.

ARTICLE II

Place Of Business

The address of the principal place of business for this corporation is 12062 Stone Crossing Circle, Tampa, Florida 33635.

ARTICLE III

Purposes

The purposes for which this for profit corporation is formed are:

- 1. To develop, market and service state-of-the-art asset management systems utilizing radio frequency identification (RFID) and communications technologies, global positioning technologies, and advanced programming.
