**ARTICLE I. - NAME**

The name of this corporation is SARASOTA TEXTURING, INC.

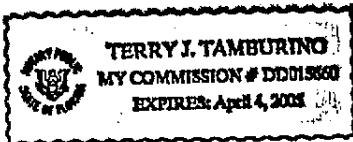
