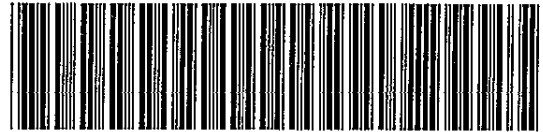

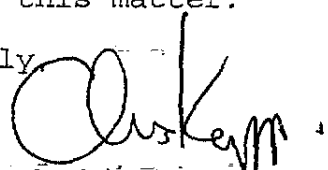

ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this corporation is
CHRIS KAPPS SOFFIT & SCREENING, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2004, and
shall have perpetual existence.

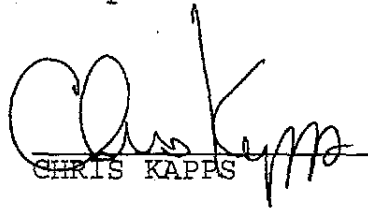

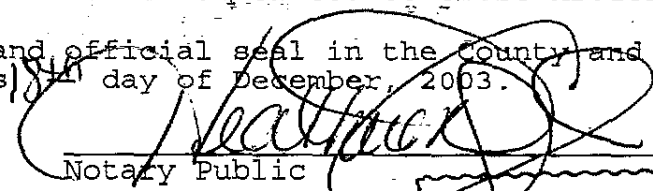

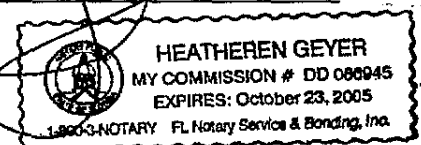
