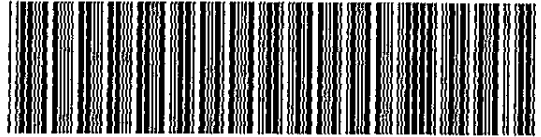

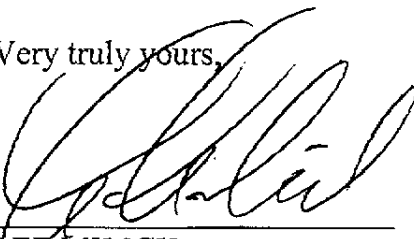

**ARTICLE I - NAME**

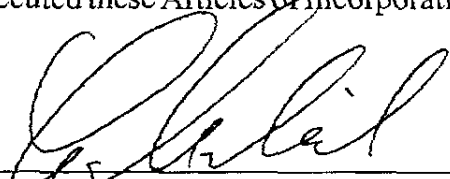

**ARTICLE IX - INDEMNIFICATION**

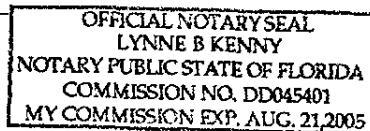
