ARTICLES OF DISSOLUTION*of***RPS-SJC, INC.**

Pursuant to Section 607.1403, Florida Statutes, **RPS-SJC, Inc.**, a Florida corporation (the "**Corporation**"), submits the following Articles of Dissolution:

ARTICLE I

The name of the corporation is **RPS-SJC, Inc.** The document number for the Corporation is P04000002180.

ARTICLE II

The voluntary dissolution of the Corporation is authorized as of May 3, 2018.

ARTICLE III

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.


ARTICLE IV

EXHIBIT A**NOTICE OF DISSOLUTION
OF
RPS-SJC, INC.**

This Notice of Dissolution is submitted by RPS-SJC, Inc., a Florida corporation (the "*Corporation*"), for resolution of payment of unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

ARTICLE I

The name of the Corporation is RPS-SJC, Inc.

ARTICLE II

The effective date of the voluntary dissolution, as specified in the Articles of Dissolution filed with the Florida Department of State, is May 3, 2018.

ARTICLE III

Claims against the Corporation should be submitted to the address listed below. The following information must be included in each claim:

3. The harm suffered by claimant.


