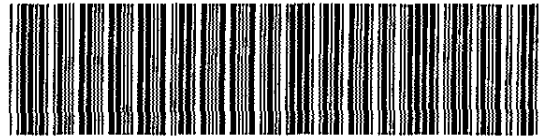

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of this corporation shall be **CSANYI DRYWALL SPECIALTIES, INC.**

**ARTICLE II. INITIAL PRINCIPAL OFFICE**

The street address of the principal office of the Corporation shall be: 6240 Trent Street, Pensacola, Florida 32503. The mailing address of the Corporation shall be 6240 Trent Street, Pensacola, Florida 32503.

**ARTICLE III. CAPITAL STOCK**

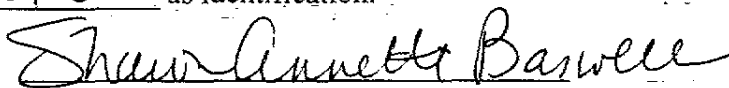
