

ARTICLE I. NAME

SECRETARY OF STATE

The name of this corporation is LARRY A. MAXSON CONTRACTOR, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the following purposes: To construct buildings and other structures, to render construction services and related activities; to employ persons to conduct such activities; to acquire and maintain assets and services needed for or helpful to the conduct of such activities; and to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
