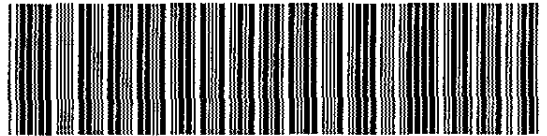

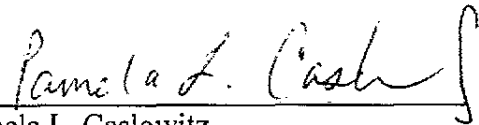
Article 8. Effective Date

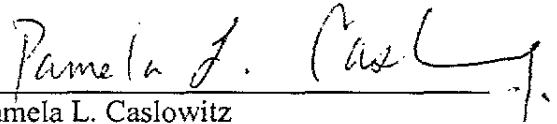
