**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

• **FIRST:** Article I of the Articles of Incorporation shall be amended to provide that:

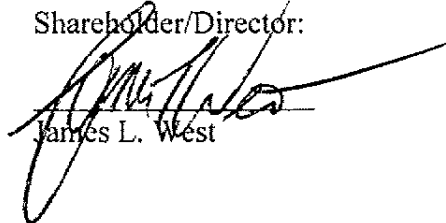
