## ARTICLES OF AMENDMENT TO

#### ARTICLES OF INCORPORATION

**OF** 

#### TERAMEDIA CORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, TERAMEDIA CORPORATION (the "Corporation") adopts the following amendment to its Articles of Incorporation:

- 1. The name of the Corporation is **TERAMEDIA CORPORATION**. The Document number of this Corporation with the Florida Dept. of State is **P04000002793**. After effectiveness of this amendment to the Articles of Incorporation of the Corporation, the name of the corporation will be "SMS MEDIA CORPORATION."
- 2. Article I of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

"The name of this corporation is: SMS MEDIA CORPORATION"

- 3. This amendment to the Articles of Incorporation of the Corporation was duly adopted by the unanimous written consent of all the members of the Board of Directors of the Corporation effective as of August 28, 2007, pursuant to the provisions of Sections 607.0821 and 607.1003 of the Florida Statutes.

This amendment to the Articles of Incorporation of the Corporation was approved by the unanimous written consent of all of the shareholders of the Corporation effective as of August 28, 2007, pursuant to the provisions of Sections 607.0704 and 607.1003 of the Florida Statutes. The unanimous written consent by the shareholders was sufficient for approval of this amendment.
- 5. This amendment to the Articles of Incorporation of the Corporation shall be effective as of the date of filing with the Florida Department of State.
