I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of States of the state of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the state of Florida.

# Article I

#### Name

# Article II

### Existence of Corporation

The Articles of Incorporation of this Corporation shall have perpetual existence.

### Article III

#### <u>Purpose</u>

The Corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the state of Florida.

## Article IV

### General Powers

- 7) To make contracts and guarantees, incur liabilities, borrow money, and issue its notes, bonds, and other obligations.
- 8) To lend money, invest and reinvest its funds, and receive and hold real and personal property as security for repayment.
- 9) To conduct its business, locate offices, and exercise the powers granted by law within or without this state.
- 10) To make and amend bylaws, not inconsistent with its Articles of Incorporation or with the laws of the state of Florida, for managing the business and regulating the affairs of the corporation.
