This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.


ARTICLE XI INDEMNIFICATION

This corporation shall indemnify any officer or director, or former officer or director, to the full extent permitted by law.


ARTICLE XII AMENDMENT
