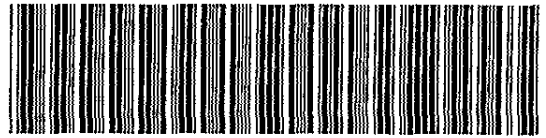

**ARTICLES OF INCORPORATION**

**ARTICLE I. NAME**

The name of this corporation is **DOMINIC BADIA CEILING TEXTURE, INC.**



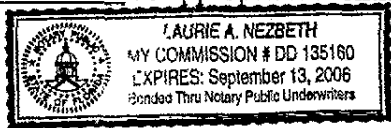
