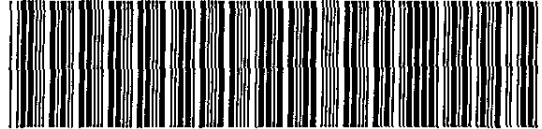



Robert L. Turner, President : 1651 Arash Circle, Port Orange, Florida 32128.


7. The incorporator of this corporation is Robert L. Turner , whose address is 1651 Arash Circle, Port Orange, Florida 32128.
