ARTICLES OF INCORPORATION

OF

BETTERBILLS, INCORPORATED

ARTICLE

The name of the corporation is BetterBills, Incorporated, (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 300 South Pointe Drive, Unit 3701, Miami Beach, Florida 33139.

ARTICLEIII

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

ARTICLEIV

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
