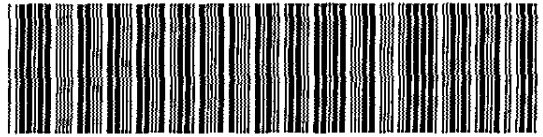

ARTICLE XII AMENDMENTS

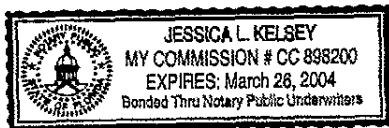


