The undersigned for the purpose of organizing and incorporating a corporation pursuant to the laws of the State of Florida, hereby makes, subscribes, acknowledges, and files these Articles of Incorporation.

ARTICLE I

NAME OF THE CORPORATION

The name of this corporation shall be: RONNIE L. GRAHAM, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal office of the corporation shall be at: 2141 Merrylene Road, Yulee, FL 32097.

ARTICLE III

DURATION OF CORPORATION

This corporation shall exist in perpetuity, unless sooner dissolved in accordance with law; and
