





ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEF FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the FLORIDA BUSINESS CORPORATION ACT, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME: The name of this corporation shall be: M.G. Masonry, Inc.
