NAME

The name of the corporation shall be Colour IV, Inc.

II.

ADDRESS

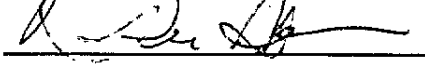

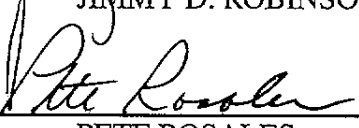
IX.

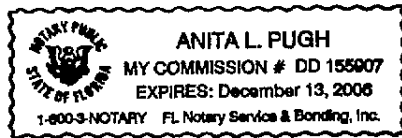
