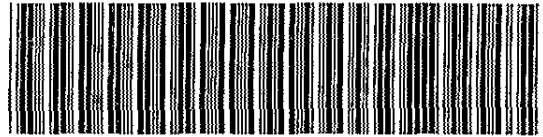



ARTICLE I. NAME

NAME: The name of this corporation is PICTURE PERFECT PAINTING OF
LAKE COUNTY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 1st day of
January, 2004.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of operating as a painting contractor
and transacting any and all other lawful business in the State of Florida and the United
States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common
stock.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the
same kind, class or series as that which he already holds, shall have the right to purchase his
pro rata share (as nearly as may be done without issuance of fractional shares) at the price at
which it is offered to others.

ARTICLE X. INDEMNIFICATION


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


