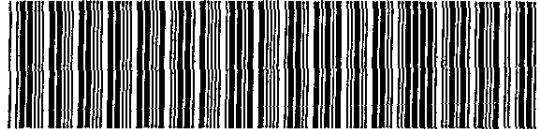

The address of the initial registered and Principal office of this Corporation is 7925 N.W 64 Street , Miami Fl , 33166.


The Board of Directors may from the time to time designate such other address and place for the registered or principal office of this Corporation as it deems fit.

The persons named initial directors shall hold office for the first year of existence of this corporation or until their successors are elected or appointed and have qualified, whichever occurs first.


ARTICLE VIII -- INCORPORATOR
