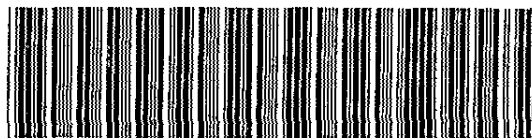

### ARTICLE II - NATURE OF BUSINESS

The purpose of the corporation shall be Residential & Commercial Painting of all types of structures, all activities legally associated within the scope of a painting contractor and all other purposes allowed by law.


