ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES 26

PM 1: 04 The name of this corporation is: BEN DIMILTA, INC., with initial principal offices located at 8524 Boysenberry Lane, Jacksonville, FL 32244.

ARTICLE II - DURATION
