The undersigned incorporator to these Articles of Incorporation hereby forms AE FINERIDE, INC. a corporation under the laws of the State of Florida as follows:

ARTICLE I

Name and Address

The name of this Corporation is: AE FINERIDE, INC. The street and mailing address of the Corporation is: 1608 Lake Drive, Cocoa, Florida 32922.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.

ARTICLE III

Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

Powers

The Corporation shall have the power:

- (a) To have perpetual succession by its corporate name.
- (b) To sue and be sued, complain, and defend in its corporate name in all actions or proceedings.
