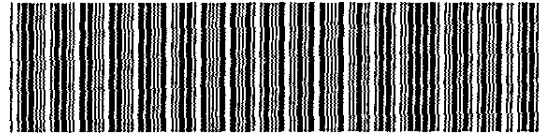

ARTICLE I – NAME

The Name of the Corporation is SHAWN WOOD TRUCKING, INC.


