# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GARDNER HOMES, INC.

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

# Article 1 - Name of Corporation


