


Gentlemen:

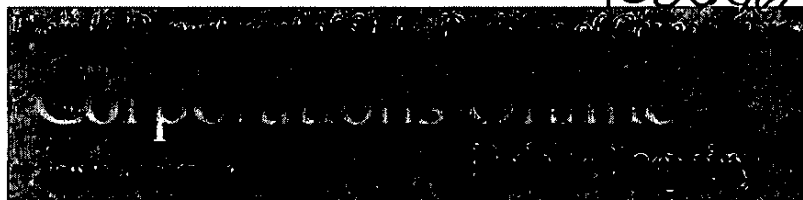
