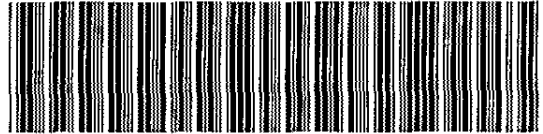


ARTICLE XI-AMENDMENT

ARTICLE XII-CORPORATE POWERS


This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act, or any Successor Statute.



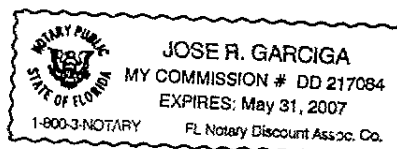
