## FIRST AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF WAYCHOFF'S HEATING & AIR CONDITIONING, INC.

## (hereafter to be known as Coles Court Holdings, Inc.)

The Articles of Incorporation of Waychoff's Heating & Air Conditioning, Inc., a Florida corporation (the "<u>Company</u>"), filed with the Division of Corporations of the Florida Department of State on January 9, 2004, as amended and restated on May 20, 2016 (the "<u>Amended and Restated Articles of Incorporation</u>"), are hereby amended pursuant to Fla. Stat. § 607.1003, as set forth in this First Amendment to Amended and Restated Articles of Incorporation (this "<u>Amendment</u>").

1. <u>Name and Document Number</u>. The name of the Company is currently Waychoff's Heating & Air Conditioning, Inc. and its document number on file with the Division of Corporations of the Florida Department of State is P04000005429.

2. <u>Amendment to Article I</u>. Article I of the Amended and Restated Articles of Incorporation is hereby amended in its entirety to read as follows:

The name of this corporation is Coles Court Holdings, Inc.

3. <u>Effective Date of Amendment</u>. This Amendment was adopted and shall be effective on December 1, 2021.

4. <u>Effect of Amendment</u>. The Amended and Restated Articles of Incorporation shall remain in full force and effect except as expressly modified by this Amendment.
