
1. The name of this corporation is FINLEY MUSIC & ENTERTAINMENT, INC. (the "Corporation")
2. Pursuant to the provisions of section 607.1006, Florida Statutes, Article I of the Articles of Incorporation of FINLEY MUSIC & ENTERTAINMENT, INC., a Florida corporation, is hereby amended as follows:

ARTICLE I  
Name
