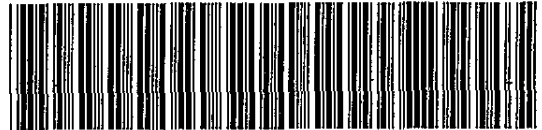

Name

Business
