# ARTICLES OF INCORPORATION OF

(Pursuant to Chapter 607 and/or 621, Florida Statutes)

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

## Article 1. Name

The name of the corporation is E. C. Labor Services, Inc., a Florida Corporation.

### Article 2. Duration


