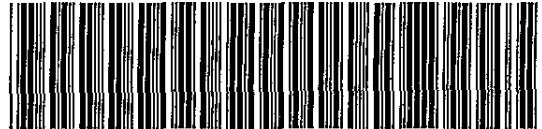

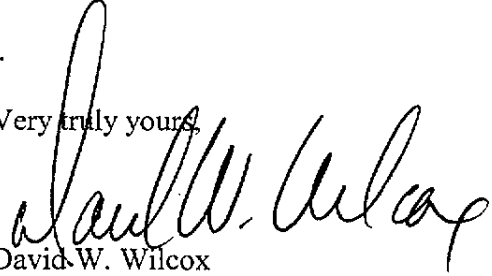

OF

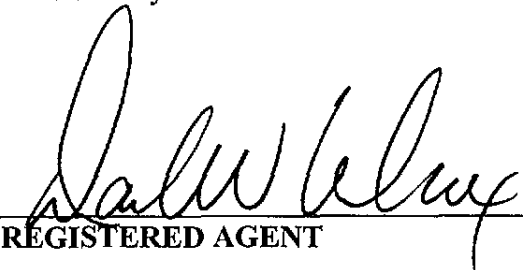
